For a valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and to induce you to honor from time to time at your sole option the purchase orders of (Name of Guarantor(s) and address) _____

of (Company Name) _____ (herein called "Purchaser"), without requiring payment upon delivery, each of the undersigned Guarantors as a primary obligor, jointly and severally, unconditionally guarantees to you, your successors and assigns, that Purchaser fully, promptly and faithfully will perform, pay and discharge all of Purchaser's obligations owing to you, according to the terms of such obligations, and agrees without your first having to proceed against Purchaser or any other person, firm or corporation, to pay on demand all sums due or to become due to you from Purchaser under any agreement between Purchaser and yourself, and all losses, costs, attorney's fees or expenses which you may suffer by reason of Purchaser's default or failure to pay.

This Continuing Guaranty may be terminated only by notice sent to you by certified mail, stating an effective date after the receipt of such notice by you; but shall continue thereafter as to each of us who has not given such notice, and shall continue as to each of us giving such notice with respect to any obligation of Purchaser to you as of the date such notice is received by you. No termination hereof shall be effected by the death of any or all of us. Each of us waives notice of acceptance thereof and of presentment, demand, protest and notice of nonpayment or protest as to any note or obligation signed, accepted, endorsed or assigned to you by said Purchaser, and we waive all setoffs and counterclaims whatsoever.

You may, without notice to us, renew, extend, or transfer such obligation of Purchaser; accept partial payments thereon; or settle, release on terms satisfactory to you or by operation of law or otherwise, compound, compromise, collect, or otherwise liquidate such obligation or security therefore in any manner; or consent to the transfer of such security without affecting or impairing such obligation of any of us hereunder.

Each and every obligor hereby authorizes any attorney of any court within the United States or elsewhere to confess judgment against obligors, either jointly or severally, to be entered by the proper official, at any time after the obligation(s) guaranteed by this instrument is (are) in default and demand hereunder has been made (whether upon normal maturity or acceleration hereunder), hereby waiving all exemptions, for the amount then due, as confirmed by an affidavit or Maryland Plants & Supplies, Inc., plus accrued late charges and actual collection/attorney's fees and court costs. Provided, however, that if the Guaranty is referred to an attorney for collection, and payment is obtained without the entry of a judgment, then obligors shall pay to Maryland Plants & Supplies, Inc. the actual attorney's fees in the amount aforesaid.

Each and every obligor/guarantor agrees that, at the option of Maryland Plants & Supplies, Inc., the venue of any suit may be laid in the state courts of Baltimore County, Maryland and hereby agree and consent to the jurisdiction of the court.

No payment by a Guarantor hereunder shall entitle that Guarantor, by subrogation or otherwise, to any payment by Purchaser under or out of the property of Purchaser, except after payment in full to you of such obligation contingently, absolutely or otherwise payable by Purchaser to you.
